### Our Mission

Lightly used equipment is refurbished and given to new, young owners.

- To ensure that ALL children with disAbilities can have access to adaptive devices which allow them to participate with others, achieve mobility, connect socially, and improve health.
- To raise community awareness that the cost of raising a child with disability, on average, costs 10 times more than the cost of raising a typically developing child.
- **3. To advocate for policy reform** so that assistive technology, as defined by the *"Individual with Disabilities Education Act,"* is accessible to all children who need it, regardless of family income.





## Key Accomplishments

To date, CATS has distributed more than 1,200 pieces of adaptive and mobility equipment to families throughout Virginia.

- Dramatic upswing in volunteer support, with more than 2,800 hours provided by nearly 200 college students, more than 50 retirees, and professional volunteers!
- Workshop established to provide a home for our *GoBabyGo* initiative, and for repairing and refurbishing equipment. This is located at Smith Mountain Lake community of Hardy, and is convenient for our retiree volunteers who handle this work.
- Our dream of a Hallowheels Fun(d)raiser made a successful debut in Roanoke, with the construction of fantastic wheelchair-mobile Halloween costumes for six local children who depend on wheeled mobility.
- Kids on the Move Expo made its debut at our Hampton Roads location. Free for families, this is a new equipment demonstration event which included 22 manufacturers and vendors.
- *Kids Equipment Palooza* is a monthly event conducted collaboratively with Lynchburg College Community Health Clinic, providing access to CATS equipment for fitting and trials.



## The Need

The average cost of a single piece of assistive technology is \$2,000.

#### The cost of raising a child with a disability is **10x** the cost of raising a typically developing child.



A child dependent on a power wheel chair for mobility may have assistive technology **costing over \$500,000 during his or her childhood,** including additional equipment for:

- Independent Mobility
- Standing
- Exercise
- Bathing
- Communication
- Community Accessibility
- Vehicle Accessibility



Yet, with the opportunities this equipment provides, this individual can attend school, college, get a job, and have a life.

### What We Do

Receive, refurbish and re-assign gently used pediatric equipment.

**Children's Assistive Technology Service (CATS)** provides for the re-use of pediatric rehabilitation equipment and assistive technology devices in Virginia.

CATS serves as a no-cost resource for children with disabilities who need adaptive equipment and whose families have limited resources.





#### Children with adaptive equipment can:

- Play with their friends and siblings
- Participate in meals and bath times
- Explore their world, moving and learning
- Be more independent

### Who We Serve

In 2017, CATS distributed 644 pieces of equipment -- serving 590 kids and their families.

#### CATS serves the entire state of Virginia!



Children, from birth to age 18+, who need assistance for mobility, positioning and communication.



The *depreciated value* of the refurbished assistive equipment given back to the community in 2017 was nearly \$800,000. If purchased new, this same equipment would cost well over \$1 million.

### Dagan's Story

If it weren't for CATS, insurance denials would be the end of the line for these kids. Instead, they are able to get the equipment they need – FREE OF CHARGE!



When Dagan outgrew her second gait trainer, she was denied a new one because the insurance company claimed that it was *"medically unnecessary."* 

Through *Kids Equipment Palooza*, a monthly event at Lynchburg College where CATS works with the DPT (Doctorate of Physical Therapy) students, CATS was able to provide Dagan with a bigger gait trainer, the Rifton Pacer, size 3.

This bigger gait trainer fits her properly, and gives her the chance of freedom, and continued practice of her walking skills. Additionally, her family donated the one she had just outgrown back to CATS.

*Kids Equipment Palooza* at Lynchburg College Community Health Clinic, sponsored by <u>Centra Foundation</u>, gives families the opportunity to request equipment from <u>CATS ROANOKE</u> <u>online</u> inventory and DPT students and local physical therapists will help with fitting and trials.
